SHORT ANSWER

1. Why has the *Canadian Charter of Rights and Freedoms* had a profound impact on Canadian police work?

ANS:

The Canadian Charter of Rights and Freedoms contains specific sections on fundamental freedoms, legal rights, equality rights, and enforcement. As such, it has increased the accountability of police officers and, in some cases, limited the powers of the police.

2. What is the *Constitution Act*, 1982, and why is it important in our study of policing?

ANS:

Under the provisions of the *Constitution Act*, the federal government is responsible for enacting criminal laws and establishing the procedures to be followed in criminal cases and the provinces have responsibility for the administration of justice. This raises some interesting questions in policing, particularly how the RCMP, as a federal police force, are involved in provincial and municipal policing. (This policing is done under contract, but how this situation emerged is an interesting facet of Canadian criminal justice). If the Constitution Act were followed "to the letter," perhaps the RCMP wouldn't be involved in municipal policing.

3. What are the key sections of Ontario's *Police Services Act*?

ANS:

The key sections of Ontario's *Police Services Act* are:

- a. a provision that gives municipalities the option of having their own municipal police force; amalgamating their police service with one or more other services; sharing police services with one or more other municipalities; contracting with the OPP to provide policing services.

4. Discuss the mechanisms that exist in Canada to ensure **police accountability**.

ANS:

The mechanisms that exist in Canada to ensure police accountability include police commissions, boards, and agencies established under provisions of the various police acts or, for RCMP officers, the *RCMP Act* exist as a measure of external oversight of policing. Boards and commissions ensure accountability at both the municipal and provincial level.

5. What is Canada's **Integrated Justice Information Initiative** and what are its objectives?

ANS:

The Integrated Justice System Initiative is a joint project of the Ontario Ministry of the Attorney General and the Ministry of the Solicitor General to facilitate a seamless flow of information among justice agencies and throughout the justice system, from policing to the courts to corrections.

This initiative, along with British Columbia's Justice Information System, represent technological approaches to 'knowledge management'. Policing occurs in a 'knowledge economy' and it is critical that information is easily accessible and takes into account the realties of contemporary crime such as the mobility of criminals and terrorists. This latter discussion is a good example of community-based strategic policing.

6. State the two key pieces of legislation that provide the **framework for police services in the province of Ontario**. Explain the purpose of these pieces of legislation.

ANS:

The two key pieces of legislation that provide the framework for police services in the province of Ontario are the *Police Services Act* and the *Adequacy and Effectiveness of Police Services Regulation*, an amendment to the *Police Services Act* introduced in 1999.

The *Police Services Act* sets out the responsibility for police services; the role and activities of the Ontario Civilian Commission on Police Services and the municipal police services boards; the mandate and duties of police officers and other police staff; the procedure and process for filing, hearing, and resolving complaints against the police; and the provisions for special investigations into policing. The *Adequacy and Effectiveness of Police Services Regulation* was designed to establish uniform service standards for police services across the province.

7. Explain why is it necessary to continually examine the **contemporary roles of the police**?

ANS:

It is necessary to continually examine the contemporary roles of police if they are to meet the needs of the community. Contemporary police services are actively soliciting the involvement of communities in preventing and responding to crime and social disorder, and communities are taking steps to ensure that police officers are held accountable for their actions.

8. What is **community-based strategic policing** and how is it different from earlier community-based policing?

ANS:

Community based strategic policing, depending on ones perception represents either a higher state of community policing or the beginning of an entirely new model of police service delivery where the central tenets are crime analysis, integration of units representing enhanced economies of scale (Halifax and the Royal Canadian Mounted Police sharing of forensic crime analysis, Integrated Proceeds of Crime Units, Integrated Market Enforcement Teams (IMETs), Integrated Border Enforcement Teams, Southern Alberta Marijuana Interdiction Team, Integrated National Security Enforcement Teams (INSET)). Key elements of the model include intelligence-led policing, and problem solving. The key concern in a post September 11 era is that the community maintains a key, collaborative role.

9. Explain how recent changes in the **crime context** have resulted in a change in policing.

ANS:

Recent changes in the crime context have seen the switch from "traditional" types of crime, such as robberies, assaults, and various types of property crimes to police services being confronted by new types of criminal activity, such as computer-related crimes, corporate crime, and organized crime. Another factor is the aging of the population, which is likely to be accompanied by an increasing fear of crime that police services must respond to.

10. Reflect upon the "**Trends in Policing**". What developments are occurring in Canadian society that will likely result in new trends in policing?

ANS:

There are currently 13 trends in policing with community policing being perhaps the most significant development in Canadian policing in the past half-century. It continues to influence how police services are organized.

ESSAY

1. Research studies suggest that **regional police forces** are efficient in a number of ways however critics counter that there are often organizational and operational difficulties associated with amalgamating police services. Discuss both the pros and cons of implementing a regional police force including the impact upon community policing.

2. What do you think is the relationship between community policing and the public's trust in the police to investigate complaints against themselves? What are some of the methods that a police agency can remain both accountable and transparent to the public?

ANS:

Student answers will vary.

In jurisdictions across Canada police activities are overseen both externally and internally.

Externally: Police commissions, boards, and agencies established under provisions of the various police acts or, for RCMP officers, the RCMP Act. Boards and commissions ensure accountability at both the municipal and provincial level. The SIU is the best example of external civilian review of police activities.

Internally: Within police services, there are "**Professional Standards**" or "Internal Affairs" units that investigate allegations of professional misconduct on the part of officers and corruption. Police officers may be held liable for violating the policies and procedures of the police service in which they work. They can also be held liable—administratively, civilly, and criminally—for their conduct. Police officers can be held accountable for conduct that occurs both on- and off-duty. Police officers who work in internal investigation units have a difficult and challenging mandate as they must investigate fellow police officers as objectively and neutrally as possible. Critics of this system argue it is impossible for the police to objectively investigate their own personnel, while those who favour this approach argue that investigations are conducted thoroughly by insiders who know policing.
