3) What is the *Canadian Alcohol and Drug Use Monitoring Survey (CADUMS)*? Be sure to discuss the sample used in the survey and the type of information produced by the survey. Finally, summarize the general trends in the use of cannabis, illicit drugs, and alcohol shown by the latest CADUMS.

The Canadian Alcohol and Drug Use Monitoring Survey (CADUMS) is an annual (1 pt) survey that collects basic drug-use statistics (1 pt) as well as determines how many Canadians' lives are affected by substance use (1 pt). The survey contacts at least 10 000 people (1 pt) from across all provinces and territories (1 pt). The survey collects data from two groups: Group 1 = Canadians aged 15–24 years (1 pt); Group 2 = Canadians aged 25+ years (1 pt).

The latest CADUMS shows the following general trends in the use of cannabis, illicit drugs, and alcohol:

- 1) Cannabis use in the past year has decreased in all Canadians aged 15 years or older (1 pt)
- 2) Illicit drug use has decreased in all Canadians aged 15 years or older (1 pt)
- 3) Drinking alcohol in the past year has decreased in Canadians aged 15–24 (1 pt)
