9. The following passage is from Szuchman (2013) – page 10

Although the current study did not address political leanings or animosity between people of different color preferences, it does provide a basis for future research in these areas. Obviously, research in this area has implications both for neighborhood (e.g., gang) and global violence. It is also possible that different color preferences might be the cause of marital discord in some cases. Thus, knowledge of fantasy character preference would be a useful predictor for peace on earth as well as marital happiness.

10. The following passage is from Szuchman (2013) – page 9

The first hypothesis was supported. The superheroes were perceived to be more patriotic and powerful than were the anthropomorphic animals. Moreover, the red and blue superheroes were perceived to be more patriotic and powerful than were the green and yellow superheroes. Color did not affect the generally lower patriotic and powerful ratings for anthropomorphic animals. As predicted, the reverse was true for the sensitive and friendly ratings. Anthropomorphic animals were perceived as more sensitive and friendly than superheroes. Furthermore, the crossover interaction demonstrated that green and yellow anthropomorphic animals were perceived as more sensitive and friendly than the blue and red anthropomorphic animals.

Determine which of the following is (are) plagiarized:
